4. FIRST AID MEASURES

4.1 Description of first aid measures

Eye contact

In case of contact with eyes flush immediately with plenty of flowing water for 10 to 15 minutes holding eyelids apart. Protect uninjured eye. Remove contact lenses, if present and easy to do. Continue rinsing and seek immediate medical attention.

Skin contact

After contact with skin, wash immediately with plenty of water and soap. Remove contaminated clothing immediately. In case of skin reactions, consult a physician.

Inhalation

Remove person to fresh air and keep comfortable for breathing. Call a poison centre or physician if you feel unwell. If breathing is irregular or stopped, administer artificial respiration.

Ingestion

If swallowed rinse the mouth with plenty of water (only if the person is conscious) and contact a poison centre or physician if you feel unwell.

Safe handling
