4.1 Description of first aid measures

Eye contact

In case of contact with eyes flush immediately with plenty of flowing water for 10 to 15 minutes holding eyelids apart. Protect uninjured eye. Remove contact lenses, if present and easy to do. Continue rinsing and seek immediate medical attention.

Skin contact

Where Diphoterine is not available, wash immediately with plenty of water and soap. Remove contaminated clothing immediately. Immediately seek medical attention.

Inhalation

Remove person to fresh air and keep comfortable for breathing. If breathing is irregular or stopped, administer artificial respiration and seek immediate medical attention.

Ingestion

If swallowed rinse the mouth with plenty of water (only if the person is conscious) and immediately contact a poison centre or physician.

7.1 Precautions for safe handling

Safe handling
